NEW CASES & DEVELOPMENTS

Summaries of current higher education cases and developments updated daily and provided electronically to members weekly; provides full text of selected cases

NACUANET

Members-only listserv and networking platform to connect with member colleagues and exchange legal information and insights

Includes over 31,000 discussions in its searchable archives

NACUANOTES

Short, concise, and practical summaries of recent important developments in higher education law or of common and recurring issues in the practice of higher education law; also intended for the benefit of other individuals on campus who can read and learn about a legal issue

THE JOURNAL OF COLLEGE AND UNIVERSITY LAW (JCUL)

The only national law review devoted exclusively to higher education law; includes scholarly articles about higher education law topics; delivered electronically

Includes a compliance matrix that provides a list of key federal laws and regulations governing colleges and universities

NACUA BENCHMARKING

Benchmarking Survey on Salaries

 Survey report that compiles aggregated salary data for college and university attorneys and the institutions they represent; conducted every 2-3 years and available for sale

NACUA Compliance Survey

• Periodic survey of chief legal officers to gather data on compliance programs, their structure, and their perceived effectiveness

NACUA SPECIAL PUBLICATIONS

Building an Effective Compliance Program: An Introductory Guide

• Electronic publication that provides concise guidance on how to understand, develop, sustain, and assess compliance programs

Managing Your Campus Legal Needs: An Essential Guide to Selecting Counsel

CLE WORKSHOPS
